For iPhone or iPad

This guide will help you download and access your interactive **Hemlibra+Me digital guide** on your Apple iPhone or iPad. You should have received your digital patient booklet in an email from your healthcare professional or from www.takingemicizumab.com. You can also use the QR code at the bottom of this guide. To access the digital patient booklet, please follow the steps below:



STEP 1: Be app ready

For **iPhone** users it is recommended that you use **Apple Books** for opening reading materials.

You should have Books available on your iPhone as part of its standard applications.

If you can not find Books, you can search for the app in the App Store and download it.



STEP 2: Open

Received via email
Open the email you have received from your healthcare professional with the Hemlibra+Me digital guide attached. **Click on the attachment and open it.** The attachment can be found at the top or the bottom of your email depending on your email provider.

Received via QR code/ website
All you need to do is **scan the QR code** and click the link that appears to open the document.



STEP 3: Download

Once you have opened the document you should be able to see the share icon (pictured above).

Scroll to find the Books app from Step 1, if you can't see it, click the more icon (3 dots) at the end and look through your app list.

Find the Books app icon and select it.

Done!

This will now be saved in your Books app. You will be able to navigate the interactive features of the digital patient booklet and access useful links.

For Android Phone or Tablet

This guide will help you download and access your interactive **Hemlibra+Me digital guide** on your android phone or tablet. You should have received your digital patient booklet in an email from your healthcare professional or from www.takingemicizumab.com. You can also use the QR code at the bottom of this guide. To access the digital patient booklet, please follow the steps below:



STEP 1: Be app ready

For android users it is **recommended that you use Adobe Acrobat reader** for opening reading materials. You will need to download Adobe Acrobat if you haven't done so previously.

You can find Adobe Acrobat in your applications store, for example "Open Play Store". Once you have downloaded the app you may need to register with Adobe to access the reader.



STEP 2: Open

Received via email
Open the email you have received from your healthcare professional with the Hemlibra+Me digital guide attached. **Click on the attachment and open it.** The attachment can be found at the top or the bottom of your email depending on your email provider.

Received via QR code/ website

All you need to do is **scan the QR code** and click the link that appears to open the document.



STEP 3: Download

Once the digital patient booklet has downloaded you will be able to open it.

You will be prompted to indicate which application to use to open the digital guide.

Choose the Adobe Acrobat option.

Done!

This will now be saved in your Adobe Acrobat app and in your device downloads folder. You will be able to navigate the interactive features of the digital patient booklet and access useful links.
